PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Subject: Regarding setting up of a separate Directorate of Karnataka State Integrated Child Protection Society for the safety of children and for proper implementation and monitoring of schemes.

Reference: Single File Proposal of The Director, Department of Women and Child Development No: KARICPS/Administration/Separate.ni-17/2018-19, dated: 13.07.2018.

Proposal

In the Budget Speech for the year 2018-19, it was announced that the protection (safety) of children is a priority of the Government and in this regard a Directorate will be set up for effective implementation of child protection schemes.

With a view to coordinating between various departments on controlling trafficking of women and children, in the State Level Anti Human Trafficking Coordination Committee meeting under the Chairmanship of the Chief Secretary to the Government of Karnataka, which was held on: 11.06.2017, In view of the fact that there is a shortage of staff in the Children's Homes and correctional institutions due to interest expressed by the officers in the Integrated Child Development Scheme (ICDS) offices, he has been instructed to submit a proposal for the purpose of making separate rules for the recruitment of staff of the correctional institutions.

The Director, Department of Women and Child Development has stated that the following programmes, which are presently under the Department of Women and Child Development, can be brought under the new Directorate to start a separate Directorate for the safety of children.

In the first phase, for proper implementation of the Integrated Child Protection Scheme, it is proposed to create an additional 160 posts including Director and other posts, and the additional funds required for the proposal will be fully borne by the state government. The Director requested this to be borne under the new account head 2235-02-102-02-0-37, and he requested an additional Rs. 754.25 lakhs for this purpose.

As per the declaration, for the proper implementation of the Integrated Child Protection Society, the programme as explained in the table which has been prepared and the expenditure of the grant has been detailed and the funds required for the implementation of the schemes of the Integrated Child Protection Society, in the single file read above, the Director, Department of Women and Child Development has submitted a proposal to the Government for providing an additional amount of Rs.754.25 lakhs to the Head of Accounts:2235-02-102-0-37 and sanction for implementation of the programme.

In the Budget Speech for the year 2018-19, the Department of Women and Child Development and The Empowerment of Persons with Disabilities and Senior Citizens and the Announcement in Serial No. 147 of the Budget Speech, child protection (safety) is the priority of the Government and in this regard, a Directorate will be set up for the effective implementation of child protection schemes. This scheme has been approved subject to the condition of utilization from the grant provided under The Integrated Child Protection Scheme (ICPS) 2235-02-102-06-059 (Integrated Child Protection Scheme) (ICPS).

All the above factors have been thoroughly examined and ordered as follows.
